LOGBOOK OF THE WORLD

Logbook of The World to Now Support CQ Awards
01/24/2012

The ARRL and CQ Communications, Inc have signed an agreement to begin providing support for CQ-sponsored operating awards by the ARRL's Logbook of the World ([LoTW](#)) electronic confirmation system. The agreement was announced jointly today by ARRL Chief Operating Officer Harold Kramer, WJ1B, and CQ Communications President Richard Ross, K2MGA.

CQ's awards will be the first non-ARRL awards supported by LoTW and will be phased in beginning with the CQ WPX award, with additional CQ awards to follow. The ARRL's LoTW system -- an interactive database recording contacts between radio amateurs -- was created in 2003 and has been adopted by 47,500 radio amateurs worldwide. It already has records of 400 million contacts and is growing weekly. The target date for beginning LoTW support for WPX is April 1, 2012. Amateurs will be able to use LoTW logs to generate lists of confirmed contacts to be submitted for WPX credit. Standard LoTW credit fees and CQ award fees will apply.

ARRL Chief Executive Officer David Sumner, K1ZZ, observed that this step gives radio amateurs throughout the world an inexpensive and convenient means of gaining credits toward CQ's popular operating awards: "LoTW has significantly increased interest and participation in the ARRL's DXCC, Worked All States and VUCC awards programs. We anticipate a similarly positive response to the addition of the CQ WPX award. Amateurs will be able to spend more time operating and less time chasing QSL cards."

CQ President Richard Ross, K2MGA, said he is very pleased to be able to move forward with LoTW support for CQ awards. "We have had excellent results with electronic confirmations for several years," he explained. "I am glad that we are now able to begin expanding that convenience to those participants in our award programs who use Logbook of The World. We look forward to a smooth launch for WPX and to the expansion of LoTW support to include the rest of our award programs, as well" Yaesu is the Principal Sponsor of the LoTW website.

On November 21, 2011 Dayton Hamvention® General Chairman Mike Kalter W8CI, announced that Charles Kaiser, KD8JZR, would take over as Assistant General Chairman of the largest hamfest in the US. Kaiser is replacing Josh Long, KD8BVD, who stepped down due to work commitments.

"I am lucky to find someone who is as committed as Charles," Kalter said. "He has served on a number of committees and knows Hamvention well. I know he will be an excellent assistant." Kaiser, who is retired, said that he considered the time requirements carefully before accepting the position and is ready to devote as much time as needed to ensure that the 2012 Hamvention is a success. Kalter thanked Long for his service and dedication to Hamvention. Long said he made the decision to step down because of changes in his career that involve travel during many of the committee meetings. "I have a great deal of respect for Hamvention and the leadership roles of the General and Assistant General Chairmen," Long explained. "I know those positions need to be filled with people who are able to give it the passion and dedication our volunteers deserve. At this time, I'm unable to continue to make that commitment to our team. I will stay on as a volunteer, as I have for the last eight years, and I will enjoy the tradition that is Hamvention."

The 2012 Dayton Hamvention opens May 18 at Hara Arena for its 61st consecutive year. According to organizers, the hamfest is expected to bring more than 20,000 people to the greater Dayton area. The three-day event includes exhibits, a flea market, forums and education sessions. Since this April 14 is the one hundredth Anniversary of the sinking of the Titanic, I would like to relate an experience I had on my last trip to Branson, MO.

We toured the Titanic Museum in Branson. It was interesting to see the artifacts and learn about the activities on board the ship.

At one point, as I turned a corner, - WOW - there was the Marconi Room with its latest (*for that time*) equipment. There were actually two rooms: a sound proof room where messages were sent and an office where those aboard could send and receive messages.

The equipment was operated twenty-four/seven by two men: Jack Phillips (age 25) and Harold Bride (22). They were not members of the White Star (Titanic) crew, but hired by the Marconi Company and had their own schedule.

I stood there and thought what it might have been like in those last hours - Much confusion and chaos. All the while, the two operators were frantically sending SOS in hopes that a ship might be somewhere nearby and would come to help rescue people. A ship, The Carpathia, was about one hundred miles away and heard the calls for help and came to the scene.

The equipment failed on Saturday night and the operators had to work through the night to restore it.

Mr. Phillips perished but Mr. Bride did survive. Through their efforts, about 700 people were rescued from the life boats.

HISTORY OF JOHNNY APPLESEED AWARD

In 1964, the amateur radio club developed the Johnny Appleseed award. Contacts for the award were made on the Johnny Appleseed net. It was a rather informal net; however, certificates were awarded for contacts. The net met on Friday evenings at 8:00PM on six meters: transmitting on 50.527 and listening on 50.697. Six meters was used to make the frequency more active.

By 1967, twenty certificates had been issued. The most significant one going to VQ9EFJ, J. Web Fleurdelys, on Segcheles Island in the Indian Ocean. This was on May 7, 1967. Contacts for his award included: Dan Parks W8CUT; Carl Drake W8MPW; and Gale Ecenbarger K8NSE. These certificates were fee free meaning they were sent from the club without expecting any cost to the awardees'.

After several years of dormancy, the club members moved to reinstate the Johnny Appleseed award. Someone had found a box of blank certificates. It was moved to have the club secretary issue the awards. More discussion followed in 1990 and the club decided to keep the Johnny Appleseed award active.

With the reinstatement of the award, it was decided that the requirement would be 15 contacts with either club members or Amateurs who are Coshocton County residents. Apples were awarded for contacts in code and on various frequencies. All bands and frequencies except the two meter repeaters would count. The major band, however, was ten meters (28.450) since it was more active than six meters. Certificates were to remain fee free.

The club found it to be rather difficult for some distant away stations to confirm the 15 contacts. The number of contacts was lowered to just one which later seemed too easy to obtain.

In 1997, the Johnny Appleseed rules included: continue to meet on ten meters on Friday evenings at 9:00.

To earn the award, five contacts with either club members or Amateurs who are residents of Coshocton County are required. If the contacts are not completed on the first check in, the contacts can be held until a subsequent time. There should be 12 hours between contacts with the same local station. If a member can be

contacted that following week, it will count as another contact. The awards are still to be fee free.

Since reinstatement of the award in 1989, Floyd Markley, N8KRS, earned the first certificate on Dec. 24, 1989. As of Feb. 6, 2004, 314 certificates have been awarded—one to New Zealand, several to Australia and Canada and the rest to stations within the United States.

In 2004, Gene Poland, KB8RAK, was appointed net manager and several members volunteered to take net control one Friday night per month.

All Exam elements available. The 2011 exam fee is \$15.00. Exact amount appreciated. Checks made out to ARRL/VEC are accepted too. A 2nd version of exam is available at VE discretion, time permitting. An additional \$15 is needed.

REQUIRED:

> **PHOTO ID** (driver's license, passport) or, when no photo ID is available, two forms of identification must be presented (birth certificate, report card, library card, Social Security card, utility bill, bank statement, Non-photo ID/driver's license, etc). Students may bring a school ID card, minor's work permit, school report card, library card and/or a written note from a legal guardian. If you don't have ID, then no exam will be administered.

> **CURRENT ORIGINAL AMATEUR RADIO LICENSE and COPY, and ORIGINAL valid CSCE(s)**. If applicable, bring the original and a photocopy of your current Amateur Radio license and any Certificates of Successful Completion of Examination (CSCE) you may hold from previous exam sessions. The photocopy(s) will not be returned. If you already have a license, then you need your FRN number on the 605 application.

> **Social Security number or FCC issued FRN.**

Already licensed, then you need the FRN number. (The FRN is viewable by doing a search for LICENSE at the FCC WTB ULS web page: <http://www.fcc.gov/wtb/uls>. Bring your Social Security Number (SSN) or your FCC issued Federal Registration Number (FRN). VEC's are required by FCC to submit either your SSN or your FRN number with your license application form. If you prefer not to give your SSN, then you may use your FCC issued FRN, if you have one. For instructions on how to register your SSN with the FCC and receive a FRN, visit the ARRL web page: <http://www.arrl.org/fcc/uls101.html>. >Bring cash, exact amount appreciated, check or money order to cover the exam session fee. We have NCVEC 605 forms at session.

NEW RULES FOR 5 MHZ (60 METERS) TO GO INTO EFFECT MARCH 5

ARLB004 ARRL Publishes New Guidelines for 60 Meters

Thanks to the FCC Report and Order issued November 18, 2011; amateurs will enjoy a number of new privileges on the 60 meter band beginning March 5, including a boost in effective radiated power from 50 to 100 W, as well as the ability to use CW and certain digital modes.

Late last year, the ARRL HF Band Planning committee surveyed 60 meter operators to gather opinions about how to best use the new privileges. On the subject of creating a specific band plan, the survey results indicated little consensus beyond the fact that 5403.5 kHz should retain its status as a de facto "DX channel." On the other hand, survey respondents made a number of suggestions for general operating practices.

Based on the survey results and subsequent research, the committee declined to propose a specific band plan for 60 meters at this time. The committee instead created a "Recommended Practices" document that is now available for downloading from the ARRL Web.

The 60 Meter pages on the ARRL Web will also be updated to reflect the changes brought about by the Report and Order.

The April issue of QST magazine will also include an article by ARRL Regulatory Information Manager Dan Henderson, N1ND, which offers a detailed discussion of the new 60 meter privileges and recommended operating practices.
