History of Johnny Appleseed Award

In 1964, the amateur radio club developed the Johnny Appleseed award. Contacts for the award were made on the Johnny Appleseed net. It was a rather informal net; however, certificates were awarded for contacts. The net met on Friday evenings at 8:00 on six meters: transmitting on 50.527 and listening on 50.697. Six meters was used to make the frequency more active.

By 1967, twenty certificates had been issued. The most significant one going to VQ9EFJ, J. Web Fleurdelys, on Segcheles Island in the Indian Ocean. This was on May 7, 1967. Contacts for his award included: Dan Parks W8CUT; Carl Drake W8MPW; and Gale Ecenbarger K8NSE. These certificates were fee free meaning they were sent from the club without expecting any cost to the awardee.

After a several year dormancy, the club members moved to reinstate the Johnny Appleseed award. Someone had found a box of blank certificates. It was moved to have the club secretary issue the awards.

More discussion followed in 1990 and the club decided to keep the Johnny Appleseed award active.

With the reinstatement of the award, it was decided that the requirement would be 15 contacts with either club members or Amateurs who are Coshocton County residents. Apples were awarded for contacts in code and on various frequencies. All bands and frequencies except the two meter repeaters would count. The major band, however, was ten meters (28.450) since it was more active than six meters. Certificates were to remain fee free.

The club found it to be rather difficult for some distant away stations to confirm

the 15 contacts. The number of contacts was lowered to just one which later seemed too easy to obtain.

In 1997, the Johnny Appleseed rules included: continue to meet on ten meters on Friday evenings at 9:00.

To earn the award, five contacts with either club members or Amateurs who are residents of Coshocton County are required. If the contacts are not completed on the first check in, the contacts can be held until a subsequent time. There should be 12 hours between contacts with the same local station. If a member can be contacted that following week, it will count as another contact. The awards are still to be fee free.

Since reinstatement of the award in 1989, Floyd Markley, N8KRS, earned the first certificate on Dec. 24, 1989. As of Feb. 6, 2004, 314 certificates have been awarded--one to New Zealand, several to Australia and Canada and the rest to stations within the United States.

In 2004, Gene Poland, KB8RAK, was appointed net manager and several members volunteered to take net control one Friday night per month.


History Tidbit

In December 1969, there was an attempt to organize a Tri County Emergency Radio Network (TCERN) which included Coshocton, Holmes, and Knox counties.

The first emergency coordinator (EC) for Coshocton County was Dan Parks, W8CUT. After the club reactivated in 1986, Bob Manson, WB8RWP, was emergency coordinator and set the first ARES net on the 145.230 repeater. His Assistant EC was Verlie Wilson, W8QDC.

In 1990, a 2 meter station was installed at the Coshocton County Sheriff's office. Plans included setting up a station at the Emergency Management office at the Coshocton County Services Building, and one was set up at the Red Cross for use in shelter setup at the Coshocton County Career Center.

Bob Manson, WB8RWP, remained EC with Warren Peiter, KC8WX, and Glenn Mitchell, KC8YV, as the assistant EC's. In 1996, Bruce Adams, KE8XM, took over the role as EC with Warren Peiter, KC8WX, as his Assistant EC. The duty of the Emergency Coordinator is to keep AREC members updated and prepared for emergency situations. The EC helps the club train through simulated emergency drills and practice nets. The EC acts as a coordinator between the Emergency Management Director and the group of AREC operators. Sandy, KC8STS
